

## **Request and Authorization to Disclose Confidential Information Under Section 13(d) of WREGIS Terms of Use**

This Request and Authorization to Disclose Confidential Information Under Section 13(d) of WREGIS Terms of Use (the “Authorization”) is entered into by the Western Electricity Coordinating Council (“WECC”) and the WREGIS Account Holder identified in the signature block of this Authorization (“Account Holder”).

1. No Modification of any Provision of WREGIS Terms of Use. This Authorization is entered into pursuant to Section 13(d) of the WREGIS Terms of Use. This Authorization is in all respects governed by, and does not modify any provision of, the WREGIS Terms of Use. All capitalized terms used in this Authorization, if not otherwise defined in this Authorization, shall have the meanings given in the WREGIS Terms of Use.
2. Request and Authorization. By signing below, Account Holder requests that WECC disclose certain Confidential Information of Account Holder as specified in Section 3 below, and gives its express authorization in accordance with Section 13(d) of the WREGIS Terms of Use for WECC to disclosure Confidential Information as specified in this Authorization.
3. Authorized Recipient; Identification of Confidential Information to Be Disclosed; Period of Disclosure. Attachment A to this Authorization sets forth (a) the party (the “Authorized Recipient”) to which Account Holder requests disclosures be made, (b) the specific Confidential Information (“Specified Confidential Information”) to be disclosed to the Authorized Recipient, (c) the frequency of requested disclosures of Specified Confidential Information to the Authorized Recipient, and (d) the date on which the request made and the authorization granted under this Authorization shall expire if not earlier terminated pursuant to Section 7 of this Authorization. WECC may provide Specified Confidential Information in either electronic (e-mail) format or paper format, at the option of the Authorized Recipient.
4. Obligations of Account Holder Applicable to Authorized Recipient. All obligations of Account Holder under the WREGIS Terms of Use with respect to Confidential Information shall apply to the Authorized Recipient with respect to all Specified Confidential Information provided by WECC to the Authorized Recipient pursuant to this Authorization. It shall be the responsibility of Account Holder to inform the Authorized Recipient of and obtain the Authorized Recipient’s legally binding commitment to abide by all applicable provisions of the WREGIS Terms of Use.
5. WECC Not Liable for Authorized Recipient’s Use of Confidential Information. WECC’s provision of Specified Confidential Information to the Authorized Recipient is an accommodation solely for the convenience of Account Holder. WECC shall have no liability to Account Holder or to the Authorized Recipient with respect to any act or omission of the Authorized Recipient in connection with the Specified Confidential Information.
6. Charges and Payment. WECC shall include in the monthly WREGIS billing statement for Account Holder, and Account Holder shall pay when due in accordance with the WREGIS

Terms of Use, all fees for delivery of Specified Confidential Information to the Authorized Recipient pursuant to this Authorization. Fees are as follows:

\$25 for an electronic copy, e-mailed to the Authorized Recipient, and  
\$50 for a paper copy mailed to the Authorized Recipient.

At the time of each delivery of Specified Confidential Information to the Authorized Recipient, WREGIS will notify Account Holder via email with an electronic copy of the Specified Confidential Information sent to the Authorized Recipient, at no additional charge to Account Holder.

7. Termination of Authorization. Account Holder may terminate this Authorization before the date (if any) specified in Section (d) of Attachment A to this Authorization by providing written notice to WECC. If WECC determines that it cannot or does not wish to continue to provide Specified Confidential Information to the Authorized Recipient, WECC may terminate this Authorization at any time by providing not less than 15 days' written notice to Account Holder. This Authorization shall terminate automatically at any time Account Holder ceases to be an Account Holder in good standing under the WREGIS Terms of Use.
