## User Types and Fees

### **Reporting Entity Program Administrator Account Holder**

The following user types do not have fees associated with their accounts. They also do not have the capability and are not permitted to conduct transactions involving WREGIS certificates:

- **Reporting Entity (Qualified Reporting Entities - QRE)**
- **Program Administrators** (*State/Provincial/Voluntary*)

### Account Holder Types

**Account Holder:** A WREGIS Account Holder is a party that has registered with WREGIS and has established an Account within the WREGIS system. Account Holder Types include:

**Generating Unit Owners:** A Generating Unit owner is an organization or individual that owns generation or is acting on behalf of the renewable energy generation facility which sends electrical power to the grid. With respect to WREGIS fees, Generating Unit Owners are categorized in four subgroups, based upon generating unit size (nameplate capacity), each with a unique fee structure. Generating Unit owners that own more than one Generating Unit may combine all of the Generating Units into a single account. When this occurs, the total sum of all Generating Unit nameplate capacity will determine into which subcategory the Generating Unit Owner Account Holder falls. The sizes of Generating Unit Owners are characterized as follows:

Generating Unit Owner Micro	<i>Total sum &lt; 30kWs</i>
Generating Unit Owner Small	<i>Total sum <math>\geq</math> to 30kWs &lt; 1MW</i>
Generating Unit Owner Medium	<i>Total sum <math>\geq</math> 1MW &lt; 10MW</i>
Generating Unit Owner Large	<i>Total sum <math>\geq</math> 10MW</i>

**Load Serving Entities** (*Electric Service Provider; Investor Owned Utility; Irrigation District; Joint Power Authority; Municipal Utility and Rural Electric Cooperative*): A LSE is an organization that provides electrical power to end use customers.

**Retail Marketers** (*Retail Marketer; Federal Marketer/Power Administrator and Marketer*): A Retail Marketer is an organization that provides electrical power to end use customers.

**Wholesale Marketers** (*Federal Marketer/Power Administrator: Marketer and Wholesaler*): A Wholesale Marketer is an organization that does not provide electrical power to end use customers, but may market power to either an LSE or a Retail Marketer.

**Utility Aggregator:** A Utility Aggregator is an entity that combines any number of utilities under a single account. The Account Holder may or may not own the utilities that have been aggregated within the account. An example of a Utility Aggregator would be an agency or authority that serves a large geographical area that is served by a number of utilities and wishes to combine the various utility's management (issuance, transfer or retirement) of certificates into a single account.

**Generator Aggregator** (*Community Choice Aggregator and Generating Unit Aggregator*): A Generator Aggregator is an entity that combines any number of generating units under a single account. The Account Holder could own, but most likely will not own the generating units. An example of a Generator Aggregator is a company that has contracted with residential photovoltaic (PV) customers and has registered the PV generating units under the Generator Aggregator's account.

**Account Holder Other** (*Broker; Public Interest Organization and Tribal Organization*): An Account Holder Other could be any number of other types of account holders that are used for descriptive purposes and may not fit into one of the categories above. Examples of this type include tribal, public interest organization or broker.
